ANNUAL CONFERENCE: THE WACUBO ANNUAL CONFERENCE IS A PROFESSIONAL DEVELOPMENT PROGRAM FOR BUSINESS OFFICERS IN HIGHER EDUCATION. EACH CONFERENCE HAS A THEME AND SPEAKERS ARE SELECTED FROM A NATIONAL POOL TO ADDRESS CURRENT ISSUES PERTINENT TO BUSINESS OFFICER IN HIGHER EDUCATION. PARTICIPANTS LEARN FROM SPEAKERS AND FROM EACH OTHER. ATTENDANCE HAS AVERAGED 512 PARTICIPANTS OVER THE PAST FOUR YEARS. IN 2020 THE CONFERENCE WAS CANCELED DUE TO THE COVID-19 PANDEMIC AND ALL ATTENDEE REGISTRATION PAYMENTS WERE REFUNDED. MOST EXHIBITOR AND SPONSORSHIP PAYMENTS WERE REFUNDED OR ROLLED OVER TO 2021.

BUSINESS MANAGEMENT INSTITUTE: THE BUSINESS MANAGEMENT INSTITUTE (BMI) IS AN ANNUAL PROFESSIONAL DEVELOPMENT PROGRAM HELD ON THE CAMPUS OF THE UNIVERSITY OF CALIFORNIA, SANTA BARBARA. BMI PROVIDES IN-DEPTH PROFESSIONAL DEVELOPMENT ON SEVERAL TOPICS OF RELEVANCE FOR BUSINESS OFFICERS IN HIGHER EDUCATION. THE FACULTY MEMBERS FOR BMI ARE PROFESSIONALS OF ACADEMIA REGARDED FOR THEIR KNOWLEDGE OF HIGHER EDUCATION MANAGEMENT AND LEADERSHIP ISSUES. THE CURRICULA FOR BMI IS CONTINUALLY UPDATED AND REFINED TO ADDRESS PRIMARY AND CURRENT ISSUES FACING WACUBO MEMBERS. THE IN-PERSON BMI WAS CHANGED TO VIRTUAL IN 2020 DUE TO THE COVID-19 PANDEMIC AFTER REGISTRATION OPENED. SOME REGISTRANTS CANCELED THEIR REGISTRATIONS AND SOME STAYED FOR THE VIRTUAL PROGRAM AND RECEIVED PARTIAL REFUNDS.
